#### **1. Your booking**

Your booking is confirmed once the required upfront payment has been received by CPD on the Sea and we have issued your booking reference number.

#### **2. What your payment covers**

An itemised invoice or booking confirmation will set out the amounts payable for this event. The CPD fee is \$1095 per participant. This fee applies to each person attending the CPD program. If a travelling guest will also participate in the CPD sessions, an additional CPD fee of \$1095 will be payable for that guest.

For this event, the relevant pricing is:

- CPD fee: \$1095 per participant
- Cruise deposit / cruise-related amount collected by CPD on the Sea: \$195
- Remaining cruise fare, payable directly to the cruise company: from \$2500\*

The cruise fare is separate from the CPD fee and generally covers accommodation for two passengers in the selected suite or cabin category. The remaining cruise fare will depend on the suite selected and availability at the time of booking. Participants will finalise their suite selection directly with the cruise company, and the remaining balance must be paid directly to the cruise company by 27 July 2026. Additional inclusions, such as onboard internet packages, may also be arranged directly with the cruise company at the participant's cost.

#### **4. What is not included**

#### **6. If CPD on the Sea cancels the CPD event**

If CPD on the Sea cancels the CPD event, the CPD fee component paid to us will be held in credit for up to 12 months and may be used toward a future CPD on the Sea event, subject to availability and any applicable price difference.

If the credit is not used within 12 months, the unused CPD fee component will be refunded less a 25% administration fee.

CPD on the Sea is not responsible for cruise cancellation fees, supplier charges, or other amounts retained by the cruise operator or other travel supplier.

#### **7. If a presenter is unable to attend**
